2. Review and Approval of February Minutes

a. Kelly Ceynowa motioned to approve. Mr. Tergilene seconded, followed by unanimous approval by the remaining members.

3. Principal's Updates -

a. Mathematical Shifts (NYC Solves) - shifting approaches to build & develop critical thinking skills. New Curriculum options are Illustrative Math (IM), iReady & Amplify Math. The District 6 schools are engaging with faculty to determine which math curriculum to adopt as a shared curriculum in Middle Schools. Superintendent Martinez is collecting recommendations from every school in the district. Teachers have been provided with demo accounts to explore all three curricula. Collected questions to pose to the district - 1. Can a school adopt a program that the district may not recommend? 2. Does each option have a paper and digital option/component? 3. How is differentiation built into each of the curricula? What were the impacts of the shift to IM - positive/negative? Can we switch back if we notice that the new curriculum is not working? Can we move the units around? Can we modify the assessments for each?

- b. State Exam updates grade 3 is paper based & 4-8 is computer based (ELA April 29th & 30th for 3-5, April 24th & 25th for 6-8 Math May 7th & 8th for grades 3-5 & May 12th & 13th for 6-8). Saturday Academy will begin on March 22nd for targeted students. Securing iReady for students in grades 3-5 to provide additional support for next 6-8 weeks this is a NYC initiative.
- c. Attendance Rate 94.4% 762 Students (enrollment increased over month)- Chronically Absent Students 22% (166 students). Students were excited to receive the monthly perfect attendance award. School will continue to send out.
- d. Kelly Ceynowa will speak at March & April PTO meetings to speak to parents about testing refusal procedures & impact on school.

4. Student Survey Results

- a._Reviewed results per grade "I feel like there is someone I can talk to", "I feel like my classmates care about me" should be addressed and we need to work on creating a space.
 - b. There is a positive to sharing results with students so they can address their concerns.
- c. Is there a possibility for team building activity (Ramapo) at the beginning of the year for 6th grade students since we have a lot of newcomers?
 - d. Team will modify the last question to be open-ended for next year.
- e. Formalize a more detailed transition to the following year give updates and share "what to expect".
